

USTAAI ELECTS NEW OFFICERS AT GENERAL ASSEMBLY

The University of Santo Tomas Alumni Association Inc. (USTAAI), on March 11, 2023 held its annual General Assembly, gathering alumni representatives and members to report on the past year's activities and achievements, recognize the outgoing officers and executive committee heads, ratify amendments to its by-laws, and elect a new set of officers. Chairman Henry Tenedero gave the opening and closing remarks.

The event culminated in the election of its president, secretary and treasurer as mandated by the amended by-laws which were ratified earlier in the program. The new officers will be responsible for overseeing the USTAAI operations, planning and organizing events and activities, fundraising in coordination with the Thomasian Alumni Community Foundation

AN INVITATION: ORIENTATION ON AMNESTY ON SEC FILING OF DOCUMENTS

The President and Secretary of all USTAAI member-AAs are invited to join a **TOWNHALL MEETING** that will be held at **9am on July 15, 2023**, at the AAI office in Rm 321 BGPOP Bldg., University of Santo Tomas, Manila.

The focus of this meeting will be the corporate status of USTAAI's member-AAs. The intention is to find out how USTAAI can assist its members in resolving their deficiencies with the Securities and Exchange Commission (SEC). For this purpose, the President, Secretary and Financial Comptroller of USTAAI will be present to answer questions.

As background, please be informed that on March 15, 2023, the SEC launched an amnesty program for non-compliant and suspended or revoked corporations. The deadline for filing amnesty applications with SEC had been recently moved to **September 30, 2023**, as provided under SEC Memorandum Circular No. 9, Series of 2023. Also, SEC has streamlined the procedure by adopting a **Unified Amnesty Application Form** which is web-based and is available on the SEC eFast. Those who are interested to avail of the amnesty are encouraged do so before the deadline as the SEC will be implementing an updated scale of fines and penalties for late and non-filing of the covered reportorial requirements starting October 1.

USTAAI BEGINS 2023 WITH RECOLLECTION

o start the year right, the Events Committee of USTAAI tapped the Alumni Priests Association (ALPA) and the College of Education Alumni Foundation Inc (CEAFI) headed by Cristina Sagum, to organize a recollection that was held on January 14, 2023. It was the first hybrid recollection hosted by USTAAI, with some 30 alumni showing onsite at the 3rd floor lobby of the Thomasian Alumni Center. This was simultaneously streamed on USTAAI FB Live. The theme of the recollection was "Hope: Dreaming Beyond Our Seeing."

The recollection began at 8:00am, with the recitation of the Holy Rosary. This was immediately followed by Praise and Worship facilitated by Christopher Maque, an animator in his student days at the College of Education.

Msgr. Bernie Pantin, ALPA president and CBCP Secretary General, spoke on the hope beyond our dreaming through Synodality, the call of Pope Francis to the Catholic church to journey together. He defined a Synodal Church as "a pilgrim community whose members live in communion and participate in Christ's mission as a priestly, prophetic, and kingly people of God."

At the end of his talk, he asked the participants to reflect on their experiences in journeying together in their parish/ community/organization, and where, in these experiences, the voice of the Holy Spirit resound. Onsite participants then shared their answers while partaking of food contributed by the different alumni associations.

The recollection ended with the celebration of the Holy Eucharist which was also streamed online at the USTAAI Facebook page.

The President's Report (2021-2023)

The University of Santo Tomas Alumni Association, Inc. (USTAAI) has remained steadfast in its mission to serve the Thomasian alumni community and has continued to uphold and exemplify the Thomasian core values of compassion, competence, and commitment. It has envisioned itself to be a cohesive, pro-active, and vibrant alumni association that effectively serves its Alma Mater, the alumni, the country, and the Church.

On May 8, 2021, the six Executive Committees of the USTAAI, namely Academics, Advocacy, Events, Finance, Public Presence, and Resource, conducted a strategic planning under the guidance of the Secretariat. The output of this planning period was published in the USTAAI Primer "The Vector," with the theme "Dreaming, Weaving, Believing, Inspiring." It served as the guide of the USTAAI in moving toward its vision 2023.

The Committee on Academics

The Academics Committee, chaired by Inocencia Ida Tionko and co-chaired by Dr. Marilyn Cano, vigorously pursued formal learning through the Academe, Alumni, Industry, Government (AAIG) conversations to address the gap between the academe and the industry. In partnership with UST Graduate School Center for Continuing Professional Education & Development, CBRC, Globe Telecom, Radius Telecoms, One Meralco Foundation, Inc., Metro Rail Transit Corporation, the Academics Committee, through its AAIG Committee Chaired by Dean Henry S. Tenedero, conducted a summit dubbed as the AAIG National Multi-sectoral Summit for Educational Transformation on September 3 and 17; and October 3 and 17, 2021. Each session was participated in by scholars, school leaders, industry, and government representatives from Luzon, Visayas, and Mindanao.

The overwhelming success of the AAIG 2021 as indicated by its rating of "Excellent" from the participants inspired the AAIG Committee to push through with its 2022 AAIG Caravan to cascade the learning gained at the Summit and stimulate the emergence of the AAIG convergence community of champions and advocates in the National Capital Region (NCR), Region 1 and Cordillera Administrative Region (CAR), Calabarzon, Visayas, and Mindanao. A maiden AAIG Caravan was held on April 21, 2022 to herald the beginning of the USTAAI AAIG 2022 Caravan Series. The NCR leg was hosted by UST. The Region 1/CAR leg was hosted by the Don Mariano Marcos State University (DMMSU), while the Calabarzon leg was hosted by FAITH Colleges. The Visayas leg was hosted by Siliman University, and the Mindanao leg was hosted by the Western Mindanao State University and the Davao Del Norte State College. In all of these caravan journeys, a total of 2,155 participants from the academe, government, and industry, attended the online Caravan Series nationwide.

USTAAI dreams of successfully building communities of practice in Luzon, Visayas, and Mindanao that promote partnership among the alumni, academe, industry, and government for the smooth transition of the fresh alumni to the world of work. The preparation for the face-to-face September 2023 AAIG National Multisectoral Summit has begun.

As part of the Academics Committee's BRIDGES life-long learning, was conceptualized and launched on October 4, 2021. This online talk show, which is streamed live on the USTAAI Facebook page and posted on our YouTube channel, provides the Thomasian alumni the opportunity to share their expertise and experiences on various topics in an informal, simple, and down-toearth manner. It has reached 100 episodes on February 28, 2023 and has featured notable Thomasians in various fields. These alumni continue to be faithful to the core values of competence, compassion, and commitment that the UST nurtured in them. BRIDGES was initially done in partnership with the Carl Balita

In the Homecoming that ensued, I was elected as a Board Member of the Law Alumni Foundation. And so began my journey as an active Thomasian alumnus, giving back to the University and the community. This was something I truly enjoyed, and which also brought me to serving in the USTAAI in various capacities. That was when I remembered my fellow llocanos who journeyed with me as Thomasian students in the 80s. And this encouraged me to help organize the Tomasinong Ilocano Alumni chapter in La Union where I come from. And the rest, they say, is history.

Review Center (CBRC) and later, with the UST Communications Bureau. All these episodes were media of Tria haec: faith, hope, and love.

USTAAI also dreams of expanding its collaboration and partnership to maintain its involvement in the academic pursuits of the University and to create an avenue for life-long learning for the alumni, faculty and students, and other related groups.

The Committee on Advocacy

Moved by compassion and by its commitment to provide access to quality education, the Advocacy Committee, chaired by Engr. Jerenato Alfante and Co-chaired by Angie S. Tuazon, launched in 2021 the first Scholarship Program of the USTAAI also under the name St. Albertus Magnus Scholarship Program. This program was able to help two students finish their college education in UST, with both scholars graduating with Latin honors.

On April 21, 2021, the USTAAI Advocacy group launched the project "Bida sa Pandemya" for the doctors, nurses and other frontliners in various hospitals in Metro Manila. Giftbags were given as a sign of our Thomasian love as we cheered the team of health workers in the ER and COVID Wards. The beneficiaries of this project were from the UST Hospital, Chinese General Hospital, San Lazaro Hospital, Philippine General Hospital, V. Luna Medical Center, East Avenue Medical Center, Philippine Heart Center, Veterans Memorial Medical Center, Ospital ng Sampaloc, De Los Santos Medical Center, and the Manila COVID-19 Field Hospital in Luneta.

In the aftermath of the Typhoon Fabian calamity on July 24, 2021, USTAAI Team Advocacy and UST Thomasian Alumni Leaders Association (TALA) organized a flash response to flood victims through the Tomasino Para sa Kapwa Pilipino project. Volunteers were mobilized and dispatched to give food packs to the affected families in various evacuation sites, namely: Brgy. Masambong and Brgy. Apolonio Samson in QC; Brgy. Burgos Elementary School in San Mateo, Rizal; Diosdado Macapagal High School in Brgy. Tatalon; and Brgy. San Jose in Rodriguez, Rizal. On July 27, USTAAI released funds amounting to Php 20,000 to help flood victims, which included the indigenous Mangyan community in Naujan, Mindoro.

On July 31, 2021, USTAAI hosted "Laro Mo, Tulong Mo" online bingo for a cause which raised more than Php 480,000. These funds have been earmarked for the Advocacy Committee's disaster response projects.

In October 2021, the USTAAI Advocacy team responded to the appeals for help in the wake of severe Tropical Storm Maring (Kompasu) in Northern Luzon. Medical and relief efforts were conducted for the affected families in the Municipality of Pudoc East, Tagudin, and Brgy. Langaoan, Sta. Maria, both in the province of Ilocos Sur.

On November 23, 2021, USTAAI partnered with the UST TALA and conducted a Tomasino Para sa Kapwa Pilipino outreach

He also expressed gratitude to the members for their support and optimism for the future.

Certificates of Appreciation were also presented to the outgoing officers and Executive Committee heads in recognition of their dedication and service towards achieving the objectives of the USTAAI.

activity to respond to the affected families in the fire-hit residential area of Barangay Manresa in Quezon City. Food packs and other supplies were distributed to a total of 300 families at Sto. Domingo Street and C3 Sgt. Rivera Street. This outreach was made possible through the donations from UST alumni Maureen Mocky Bollozos Pickering, Atty. Ellen Francisco, and the Quezon City Dynamics Lions Club. Other sponsors included Baker's Fair, owned by UST Faculty of Pharmacy Alumni, Christopher Ong, which donated bread, and the UST Atelier Alumni Association, through its president Marissa Pe Yang, that donated rubber slippers.

On December 24, 2021, under the leadership of Angie S. Tuazon, Chair of the Committee on Tomasino Para sa Kapwa Pilipino Disaster Response, and in partnership with UST TALA, UST SIMBAHAYAN, and through the financial assistance from member alumni associations, USTAAI extended help to the victims of Typhoon Odette by way of sending food packs, water purifiers, water, blankets, and used tarpaulin sheets to the affected communities of Bilar, Bohol. A brand new generator was donated to the Dominican Daughters of Immaculate Mother School through Sr. Eva Abellano, OP. On December 27, 2027, with the help of Angels on Wheels from Tacloban, relief goods were distributed in the municipalities of Tomas Oppus, Libangon and Anahawan in Southern Leyte. The outpouring of assistance and donations continued until the first quarter of 2022, which enabled the USTAAI Advocacy team to extend support to the typhoon victims by shifting to rehabilitation efforts. With the support of the Women in Infrastructures Foundation Inc. (WIFI), whose President is Atty. Ma. Elena G. Francisco, who, at the same time, was the President of the Law Alumni Foundation Inc (LAFI), USTAAI was able to respond to the appeal for assistance of the parish priests in reconstructing their churches. With the help of the Alumni Priests Association (ALPA), several parishes in the different municipalities of Siargao were identified. The beneficiaries included the Sta. Ana Parish & Nature Kids Siargao in Burgos, Our Lady of Mt. Carmel Parish & SPAR Animal Shelter in Del Carmen, Sto. Tomas de Villanueva Parish in General Luna, Sta. Monica Parish in Sta. Monica, and Our Lady of The Pillar Parish in Pilar. More than 700 pieces of Hardiflex boards and sheets amounting to Php1M were distributed to these parishes.

The fifth edition of the Rector's Cup: Thomasian Alumni Golf Tournament drew 211 alumni golfers and guests to join the advocacy in funding the university's student-athletes who compete in national and international sports events. The tournament, organized by the Office of Alumni Relations (OAR), was held at the Forest Hills Golf & Country Club in Antipolo, Rizal on February 6, 2023.

This year's tourney intended to reinvigorate the sense of solidarity with and loyalty of the alumni to the university after the two-year hiatus due to the pandemic. Sponsors such as Wilcon Depot, Divina Law, DATEM, Inc., and Shinagawa Lasik & Aesthetics also rejoined and guaranteed their commitment to the cause. The full day event saw the dedication of the community that brought in the largest turnout of golfers since the tournament's inception.

Tournament Chairman Dr. Ian Laurel highlighted the series' distinction from other tournaments where different college teams host the competition every year. "This fosters the engagement and participation of all alumni, making it more exciting, bigger, more vibrant, and more relevant each and every year," said Dr. Laurel during the post-tournament interview. He also expressed his admiration for the support and leadership of the Rector which inspires them to continue with the advocacy.

D. Tiongco, O.P., JCD, and IPEA Director and Regent Rev. Fr. Rodel S. Cansancio, O.P. The ceremony was hosted by Faculty of Engineering Team Captain Engr. Ronaldo Fernando and Dr. Laurel.

Ten teams which consisted of different colleges and a high school department competed over the coveted perpetual championship trophy created by Arch. Ramon Orlina. The teams of the Faculty of Engineering and the Faculty of Pharmacy tied at 571 points. However, the Pharmacy team clinched the third runner up title with 9 birdies in Team Event while the Engineering team only birdied 2 placing them at the fourth place. The first time podium finisher, Faculty of Arts and Letters team, unexpectedly sealed its 2nd runner up finish

with 568 points. A great upset met the College of Science as their team committed a couple of errors, garnering them 562 points which took them a few steps back from defending the crown. Meanwhile, the Rector's Cup 3-time champion Faculty of Medicine & Surgery team made a comeback with only 557 points, thus securing the top spot for this year's event.

For the sixth Rector's Cup, the College of Architecture will host the competition with Arch. Eduardo Casares as Tournament Director. He aims to make it bigger in terms of golfer population and funds collected for the beneficiaries under his helm. He also intends to tap other forms of media to spread more awareness of the cause.

giving project dubbed as *Tala ng Pasko* on December 16-24, 2021, with nine communities benefiting from this project.

This activity was done in partnership with the UST Research Center for Social Sciences and Education, UST Junior and Senior High schools, and UST Education High School. On November 15, 2022, the USTAAI Advocacy Committee went to the evacuation centers in Bagumbayan Elementary School, San Ildefonso Parish, Filemon T. Lizan Senior High School, and the Centennial Park in C4 to distribute relief goods to 400 families affected by the fire in Barangay Bagumbayan, North Brgy. Navotas West in Navotas City.

At present, there is an ongoing fund raising through the sale of the sculptures Majestic Tiger and Lady Justice under the initiative of Angie Tuazon and Marissa Pe Yang. It shall continue while supply lasts.

The USTAAI dreams of efficiently and effectively serving the marginalized communities and disaster victims, and significantly contribute to a sustainable environment in partnership with the Thomasian Alumni Community Foundation Inc. (TACFI).

The Committee on Events

To promote Thomasian pride and solidarity, the Committee on Events, chaired by Dr. Rollo Milante, and Co-chaired by Assoc. Prof. Evangeline Timbang held various social and spiritual activities. In the last two years, the Committee remained unwavering in conducting the following activities: The Committee is preparing for a "Thomasian Icons" alumni homecoming featuring Santacruzan on May 6, 2023. The activities that are in the pipeline are Cultural Exhibit and provincial tours dubbed as "Trip natin 'to", both under the leadership of the provincial alumni chapters.

USTAAI dreams of promoting the Thomasian identity, strengthening Thomasian alumni solidarity, providing opportunities for the Thomasian alumni community to share their talents.

The Committee on Finance

Financial stability is vital to any organization. The Committee on Finance, chaired by Maria Elena J. Manansala ensures the smooth cash flow and financial stability of the Association through steady collection of revenues and judicious utilization of funds.

It takes charge of the coffee table book entitled "Thomasian Icons: Bridges of Faith, Hope, and Love," a joint project of the USTAAI and the Thomasian Alumni Community Foundation, Inc. (TACFI).

The Committee has maintained transparency by way of efficient recording and clear monthly financial reporting. It dreams of increasing its revenue from the solidarity contribution and other fund-raising activities of the Committee on Resource.

Committee on Public Presence

Today's technology has empowered the Association to reach more Thomasian alumni through various social media platforms. The Committee on Public Presence effectively promotes alumni activities and noteworthy alumni news and stories, and manages and monitors the Association's presence in different media, including this Newsletter, Facebook, Youtube and the USTAAI website.

The USTAAI Facebook page has

dramatically increased its visitors in the past 2 years and has reached a major milestone of reaching 10K followers in June of 2022. It has gained more than 13,500 followers, up by 250% since 2021, with a monthly average gain of 200 followers. With the growing number of followers, our posts on the USTAAI page has reached more than 1.1million people on Facebook and almost 400K engagements gained through post likes, comments and shares.

On March 2, 2021, the USTAAI website went online for the first time. It has provided the member alumni associations a medium to showcase their association's profile information and has been a source of social media materials for various USTAAI events, including the AAIG and the Thomasian Alumni Community newsletters.

The USTAAI Thomasian Alumni Community Youtube Channel was successfully launched on July 10, 2021. More than 300 videos have been published, which includes all BRIDGES episodes and various USTAAI events. Since its launching, the videos have gained more than 12K views.

In 2021, with the help of the member alumni associations, USTAAI was able to mobilize the participation of notable Thomasian alumni in promoting the different social media platforms through "Tomasino Shout-out" recorded video messages which were published on both the Facebook page and Youtube channel.

The Association, through its Public Presence committee, remains committed to build its brand, and to strengthen its social media presence with innovative ideas in improving and creating more content in order to gain more followers, subscribers and viewers on its Facebook page, Youtube channel, and USTAAI website.

The Committee on Resource

The Committee on Resource, chaired by Teresita Meer and Co-Chaired by Maureen Pickering launched the Thomasian Alumni Community (TAC) Patrons and the TAC Exchange, an online market of the USTAAI in 2021. The TAC Patrons has been temporarily suspended due to the difficulties of the times.

Through the TAC Exchange, Resource Committee was able to sell unique handpainted bayongs, alumni T-shirts, and is currently in partnership with Melaleuca and I-fern, both selling beauty and wellness products. Melaleuca is also a source of excellent and environmentally friendly cleaning products.

As we emerge from the pandemic, the USTAAI Committee on Resource dreams of increasing the number of TAC patrons and increasing the number of transactions in the TAC Exchange.

Secretariat

Aside from these major roles, the Secretariat supervises the production of the TAC Newsletter, the official newsletter of the USTAAI. It also led the Association's online Christmas party on December 11, 2021, and the December 10, 2022 USTAAI Christmas party, held in partnership with the Office for Alumni Relations (OAR).

The Committee took charge of the planning and evaluation of the Executive Committees and officers at Royale Estate Club House, Alfonso, Silang, Cavite on February 18, 2022; organized the USTAAI contingent to the Tomasinong Ilokano La Union Alumni Association Launching and Oath taking on June 20, 2022; and initiated the teambuilding program of the USTAAI at Caleruega, Nasugbu, Batangas on August 30 - September 1, 2022.

It coordinated the Rest and Recreation of the USTAAI at the Munting Paraiso at Lipa, Batangas on February 25, 2023, and supported the AAIG Committee during the MOU signing between the USTAAI AAIG with the DMSSU on June 21, 2022.



UST CAMPUS IN MY MEMORY: Oasis in a Concrete Jungle, Wellspring of Growth and Development



was born in the UST Hospital due to its proximity to our grandmother's old business near Padre Campa Street. My father and some of his siblings finished school in UST. That was a foreshadowing, I guess, that I would one day end up a Thomasian. Little did I realize it would be a 28-year stay in the sprawling España campus—and I haven't left since 1995.

Join me in this recollection of the UST campus—from the memories of a 16-year occupant of the Albertus Magnus Building who eventually studied, taught, or held office in the other structures.

Oasis in a concrete jungle

I entered UST as a Kindergarten pupil in June 1995, five months after Saint Pope John Paul II drew thousands to the historic Open Field. Perhaps that's one way to describe several of UST's spaces back in the mid-1990s—Open.

Of course, more structures have sprung forth in contrast to the 6os to the 8os, but still, back then we had the Colayco Park where we performed in 1998, the statues of the Nine Martyrs fronting the old Dapitan Gate (there used to be a gate directly facing Asturias instead of the two gates we now have), the Engineering Sports Complex which was essentially a covered court, and the famous and trusty White Thumb coop, beside it.

As a "Little Thomasian" at the turn of the millennium, we still had field demonstrations in the Open Field and the old PE spaces on which the Quadricentennial Pavilion and Carpark now stand. Speaking of PE, the old Gymnasium still had its old art deco design back then, with the classic spiral staircases on both sides.

Fast forward to the early 2000s, the sprawling space that is the eastern counterpart

of the Open Field and the Grandstand (according to alumni, it was called Area B in the 1980s) began to have structures built on them. Soon, students in the Education and Engineering buildings bade goodbye to the Sports Complex, the Coop., and the Playground. They then said "hi" to the Multi-Deck Carpark with its concessionaires and its first occupant: the UST-Alfredo M. Velayo College of Accountancy. Back in high school, SM Mall of Asia was inaugurated, and we were so amazed that McDonald's, KFC, Ice Monsters, and Beanhoppers were in the carpark, so we said it's UST MOA: the Mall of Accountancy.

After Typhoon Milenyo in 2004 toppled many of the trees in the Benavides Garden (unofficially the Lovers' Lane), the central greenery of the campus also underwent various stages of improvement. In time, what used to be an area filled with diverse trees and bushes became a space where nature blended with art. It soon lit up at night during Paskuhan season and became a scenic spot in its own right.

The Nine Martyrs along Dapitan also gave way to the Tan Yan Kee Student Center, inaugurated in 2006. Though their likeness was in a sense, martyred (pun half-intended), the ground of which their statues were razed became a fertile patch of land for the formation of Thomasian student leaders. A witty Dominican friar shared to us student leaders that he received several questions like: "Where are the martyrs!?" He simply replied: "They're in Heaven!"

The construction works of the mid-2000s is, l guess, best represented though not by an edifice that's tall, but by a space that's flat: the Plaza Mayor. Gone were the days when vehicle exhaust pipes would "perfume" the air in front of the iconic Main Building, which was fronted for decades by parking spaces. Now, there was nothing but a flat expansive space that removed all distractions from the human eye. The only focus was what lay ahead: the Main Building.

And from that same historic building, specifically its tower, did a grand fireworks display erupt six years later, on January 28, 2011, when UST turned 400. As a longtime student accustomed to fireworks displays at the Grandstand, seeing it erupt from the Main Building was a marvel. And the night before, when the clock struck midnight on January 28, 00:00 hrs., the otherwise dark sky momentarily looked like day, when the blinding fireworks from the Grandstand met the display emanating from the Chapel.

As UST chiseled the 400th line in its counting of years, it also chiseled the name "UNIVERSITY OF SANTO TOMAS" on a rectangular granite marker on the side of the Arch of the Centuries. That marker remains to be the only label near the campus perimeter that says we're UST. That 22-letter name and the slab on which it is chiseled blocks from view a metal cylinder encased in the marker in 2011. It is the Quadricentennial time capsule containing our names (the Quadri. graduates) and various other items that would show what 2011 was to people of 2061 or 2111.

That time capsule would tell Thomasians of memories which we would no longer be able to tell by that time. But that's a tale for another time.

What are my campus memories? Twentyeight years provided me with plenty, but perhaps by recalling the spaces I once saw, you can share in my memories, too, and remember the good ol' days when we were formed in the oasis of Manila's concrete jungle.
